Bennetts Associates launches new anti-greenwash charter

Practice launches charter to 'cut greenwash' and encourage productive conversations around sustainability in the built environment.

Produced for architects, engineers and journalists, Bennetts Associates' new charter: 'Tell The Truth: A campaign for honesty in the built environment' looks to encourage a collective stance against greenwash tactics. At its core the charter examines common 'sustainability' themes, with clear rules to improve transparency and honesty and prevent greenwash. The first signatories include members of the Built Environment B Corp group.

The charter seeks to encourage the industry's professionals to move beyond unhelpful discourse emphasising that claims need to be clearly evidenced and explained. Aiming for simplicity, the charter is a short list of dos and don'ts that are easy to monitor and more importantly easy to uphold.

Signatories to the charter will utilise in-use or accurate predictive data as far as possible to demonstrate energy and carbon credentials – this is instead of compliance assessments which are often highly flawed. As active members of the UKGBC, LETI and the upcoming Net Zero Carbon Building standard Bennetts Associates recognise the work being done by others and as such the charter is not intended as 'another set of standards' or targets. Instead, the charter focuses on reinforcing these by making sure that they form the basis of communications.
